ORDER

The Lt. Governor is pleased to approve dovetailing of IAY Scheme with other State Housing Schemes in the Union Territory of Puducherry.

2. The Indira Awaas Yojana (IAY) Scheme is a Centrally Sponsored Rural Housing Scheme implemented in the Union Territory of Puducherry since 1985 onwards, at present an amount of Rs.45,000/- per beneficiary is extended as Central Share and State Government is giving Rs.55,000/- under State Government Budget to extend per beneficiary upto Rs.1,00,000/-
3. The Rural Development Department through its District Rural Development Agency (DRDA) will contribute Rs.45,000/- per beneficiary from Central Share provided the beneficiary
- 1) Satisfies IAY Guidelines/eligibility criteria
 - 2) Their name finds place in IAY wait list
 - 3) a certificate is given by respective agency / department that the beneficiary has not availed any subsidies under their departmental housing schemes.

4. The list of identified BPL households as identified by DRDA both for SC and Non-SC in entire UT of Puducherry (list of soft copy enclosed) will be shared with Slum Clearance Board and Adi Dravidar Welfare Department, after retaining sufficient funds to implement IAY Scheme by DRDA for the Current Financial Year. Out of the remaining funds, 60% funds will be released to Adi Dravidar Welfare Department and 40% of the funds will be released to Slum Clearance Board which should be deposited and operated in separate bank account for IAY mingling them with other funds.

5. The Utilization Certificates and expenditure statements for the funds released has to be furnished to the DRDA periodically by the said Department/Agency for onward transmission to the Ministry of Rural Development, Government of India.

6. The Project Director, District Rural Development Agency is authorized to release the Central Share to the concerned State Government Housing Agencies/Department on fulfilling the above conditions.
